The NRBA mourns the passing of Court of Appeals Judge Sheila Abdus-Salaam. She was a friend of the NRBA who attended the last three Court of Appeals dinners and who served as the key note speaker at the 2016 dinner. A graduate of Barnard College and Columbia Law School, Judge Abdus-Salaam began her legal career at East Brooklyn Legal Services, followed by the New York State Department of Law and New York City Office of Labor Services. She commenced her judicial career by serving on the New York City Civil Court, and later, to the New York State Supreme Court. In 2009, Governor Cuomo designated her to the Appellate Division-First Department. In April and May 2013, Judge Abdus-Salaam was nominated and confirmed to serve on the New York State Court of Appeals.

A public memorial service will be held on May 26, 2017 at 11 AM at the Cathedral of Saint John the Divine, 1047 Amsterdam Avenue, New York City.

On April 17, 2017, NRBA member Joyce Furfero, a professor at St. John's University, and Corey Andrews, a 5<sup>th</sup> grade teacher at Ward Elementary School, will conduct a 2 credit CLE training session for our volunteers. ## PRESIDENT TRUMP'S EXECUTIVE ORDER REGARDING IMMIGRATION IN THE UNITED STATES By Douglas Stone, Esq.

President Trump issued three Executive Orders on immigration on January 25, 2017 – "Executive Order: Enhancing Public Safety in the Interior of the U.S.", "Executive Order: Border Security and Immigration Enforcement Improvements", and "Executive Order: Protecting the Nation From Foreign Terrorist Entry Into the United States".

This article focuses on key sections of the Order regarding "Enhancing Public Safety in the Interior of the United States". New Rochelle and the New York area, which have large immigrant populations, are particularly affected.

## Section 1. Purpose

President Trump asserts that "Many aliens who illegally enter the United States and those who overstay or otherwise violate the terms of their visas present a significant threat to national security and public safety." Most research, though, indicates that undocumented immigrants commit crimes at lower rates than natural born citizens.

The Order continues: "Sanctuary jurisdictions across the United States willfully violate Federal law in an attempt to shield aliens from removal from the United States. These jurisdictions have caused immeasurable harm to the American people and to the very fabric of our Republic."

The term "sanctuary jurisdiction" generally refers to a jurisdiction which permits residence by undocumented immigrants by refusing to help the Federal government enforce immigration laws. These jurisdictions prohibit police from questioning people about their immigration status. California, Connecticut, New Mexico, Colorado, New York City and Nassau County are known as sanctuary jurisdictions. New Rochelle, Mamaroneck, Port Chester, Yonkers and White Plains are local cities that welcome immigrants. Despite the statement in the Order, no federal law requires local jurisdictions to aid ICE (U.S. Immigration and Customs Enforcement).

President Trump states in the Order: "We cannot faithfully execute the immigration laws of the United States if we exempt classes or categories of removable aliens from potential enforcement. The purpose of this order is to direct executive departments and agencies to employ all lawful means to enforce the immigration laws of the United States." These words suggest the Trump Administration wants to deport (remove) the estimated 11 or 12 million people who are here illegally. Opponents consider this an unrealistic mission that the country lacks the will or resources to execute.

## Section 2. Policy

President Trump states, among other things, that "It is the policy of the executive branch to....ensure that jurisdictions that fail to comply with applicable Federal law do not receive Federal funds, except as mandated by law." On March 27, 2017, Attorney General Jeff Sessions highlighted this policy at a press conference at the White House.

### Section 4. Enforcement of the Immigration Laws in the Interior of the United States

President Trump states "...I hereby direct agencies to employ all lawful means to ensure the faithful execution of the immigration laws of the United States against all removable aliens."

### **Section 5. Enforcement Priorities**

President Trump stated a dramatic change in enforcement policy to prioritize for removal all removable aliens, including those who "Have been charged with any criminal offense, where such charge has not been resolved..." This means that, if enforced, an alien who entered legally on a nonimmigrant visa, overstayed, and was then charged with a crime, could be put in removal proceedings while the charge is pending. It is unlikely this would survive legal challenge. As to prioritizing for removal all removable aliens, there is a saying that if everything is a priority, nothing is a priority.

This new policy reverses the Obama Administration policy, which prioritized enforcement and removal policies, using prosecutorial discretion, to focus on aliens who were threats to national security, who were apprehended at the border or a port of entry while trying to illegally enter the U.S., and those convicted of felonies, unless they qualify for asylum or other legal relief.

# Section 7. Additional Enforcement and Removal Officers.

The President states that the Secretary of Homeland Security shall act to hire 10,000 additional immigration officers, to be trained and authorized to perform law enforcement functions. On February 20, Secretary Kelly announced that ICE will act to expeditiously hire 10,000 agents and officers. Immigration advocates worry that these new employees will be inadequately trained and supervised and may act aggressively and illegally. Local police in many jurisdictions, including New Rochelle and New York City, have objected to authorization for ICE agents to perform legal functions.

## Section 8. Federal-State Agreements.

The Order states: "It is the policy of the executive branch to empower State and local law enforcement agencies across the country to perform the functions of an immigration officer in the interior of the United States to the maximum extent permitted by law." It further states: "to the extent authorized by Secretary shall take appropriate law...the action...to authorize State and local law enforcement officials, as the Secretary determines are qualified and appropriate, to perform the functions of immigration officers in relation to the investigation, apprehension, or detention of aliens in the United States under the direction and the supervision of the Secretary."

## Section 9. Sanctuary Jurisdictions.

The Order states that the Attorney General and Secretary of DHS, in their discretion, "shall ensure that jurisdictions that willfully refuse to comply with" ICE's efforts to detain removable aliens "are not eligible to receive Federal grants", except as the Attorney General or Secretary deem necessary for law enforcement purposes.

President Trump further states: "To better inform the public regarding the public safety threats associated with sanctuary jurisdictions, the Secretary shall utilize the Declined Detainer Outcome Report or its equivalent and, on a weekly basis, make public a comprehensive list of criminal actions committed by aliens and any jurisdiction that ignored or otherwise failed to honor any detainers with respect to such aliens." ICE issued its first such report on March 20, 2017.

# Section 10. Review of Previous Immigration Actions and Policies.

President Trump states: "The Secretary shall immediately take all appropriate action to terminate the Priority Enforcement Program (PEP)..." and reinstitute the "Secure Communities" program. Secure Communities is a program, started in 2008, that relies on cooperation between Federal, state and local law enforcement agencies and was designed to identify prisoners who are deportable. The Obama Administration ended it in 2014 because it drove a wedge between immigrant communities and local law enforcement. Governors, mayors, states and local law enforcement refused to cooperate with it and many federal courts rejected local law enforcement's authority to detain people under the program.

## Section 13. Office for Victims of Crimes Committed by Removable Aliens.

The President states that the Secretary will establish this office and it "shall provide quarterly reports studying the effects of victimization by criminal aliens present in the United States." He highlighted this plan in his address to Congress on February 28. Senator Bernie Sanders criticized Trump's use of victims to promote his agenda, stating "He is stirring up fear and hatred against immigrants and trying to divide our nation."

## Section 14. Privacy Act.

President Trump states: "Agencies shall, to the extent consistent with applicable law, ensure that their privacy policies exclude persons who are not United States citizens or lawful permanent resident from the protections of the Privacy Act regarding

personally identifiable information." DHS Secretary Kelly later stated that ICE will collect and report data on Alien Apprehensions and Releases. He states that ICE shall provide monthly public reports regarding apprehended aliens, including these categories: "country of citizenship, convicted criminals and the natures of their offenses, gang members, prior immigration violators, custody status of aliens, and, if released, the reason for release and location of their release, aliens ordered removed, and aliens physically removed or returned." He also states that ICE shall publish weekly reports "of non-Federal jurisdictions that release aliens from their custody, notwithstanding that such aliens are subject to a detainer or similar request for custody issued by ICE to that jurisdiction." It appears the purpose of the reports is public shaming. People who willingly disclosed information during the Obama administration, such as for Deferred Action for Childhood Arrivals, fear that the government may use this information to deport them and family members.

President Trump's Order and statements regarding immigration law enforcement have created huge anxiety in the immigrant community. He has suggested that all removable aliens are targets and has done little to clarify the reach of his new policy.

On January 26, 2017, New Rochelle Mayor Noam Bramson, City Manager Chuck Strome and Police Commissioner Patrick Carroll issued this statement:

"Yesterday, President Trump issued executive orders related to immigration, one of which concerns coordination between Federal immigration authorities and local police departments....The term 'sanctuary city' has no precise definition, and we do not use it in New Rochelle, but we do make absolutely clear that all people of good will are welcomed, valued and respected in our community, regardless of their origins, and that immigrants are an essential part of New Rochelle's identity and future. For our Police Department, maintaining a respectful and mutually supportive relationship with all constituencies is not just the right thing to do, it

respectful and mutually supportive relationship with all constituencies is not just the right thing to do, it is also necessary to the promotion of public safety, which depends on trust and the free flow of information. That is why local police departments are not and should not engage in immigration enforcement – and our practices in New Rochelle reflect and support this principle. Of course, the New Rochelle Police Department will continue coordinating with federal authorities to apprehend and bring to justice criminals who threaten our safety, regardless of their immigration status."



## COLLABORATION BETWEEN THE NRBA AND THE NEW ROCHELLE PUBLIC LIBRARY FOUNDATION UPDATE By Ronald V. Zezima, Esq.

The NRBA and the New Rochelle Public Library Foundation ("NRPLF") are collaborating on a series of "Law in the Library" workshops offered to the public for free at the New Rochelle Public Library. The NRBA provides panels of speakers on various topics of general interest.

On March 27th, the Bar Association in conjunction with the New Rochelle Public Library Foundation ("NRPLF") co-sponsored the second in a series of "Law at the Library" events, entitled "Inside the New Rochelle City Court".
